Paula is president of the consulting firm TASCA Global and is a frequent expert guest on CNN and CNN International.

ABOUT THE AIB-ANZ CHAPTER MEETING

Scheduled at the transition period between teaching and the summer 'paper writing' season, the AIB-ANZ chapter meeting allows the region's International Business researchers to come together as a community and network, be reinvigorated, and re-focus our research efforts ahead of a summer of research productivity.

The meeting includes a **research symposium** on 11 November, where authors are able to present and receive feedback on their early-stage research ideas from peers, prior to working up papers for submission to journals or conferences. To benefit from this opportunity, a one-page abstract (up to 750 words) is all that is required for submission.

The AIB-ANZ meeting includes a half-day **paper development workshop** (PDW), which will take place on 12 November. Facilitated by distinguished IB academics, this workshop will help you to refine and develop your paper in preparation for submission to a high-quality journal. PDW participation requires the submission of a full paper draft.
