Dear Worldwide Members of the Academy,

To prepare for this year's duties as President of the Academy of International Business, I have given much thought on the best ways to give back to an organization that has been an integral part of my professional life for the past several decades. As of mid-June, 2015, we have nearly 3,400 members from 87 countries/ economies from around the world. The composition of the 2015-2016 AIB Executive Board (http://aib.msu.edu/executiveboard2015-16.asp) also reflects this diversity. After pondering over these statistics and reviewing the latest developments at the AIB board level (presented susbsequently), many of which are memberdriven, I have arrived at the conclusion that the most meaningful course of action is to take the lead in encouraging all of us to celebrate the commonalities yet differences that bind us together as members of this incredible organization. It goes without saying that this effort can only succeed with your concerted support and assistance.

Diversity is perhaps one of the most distinguishing characteristics of the Twenty-first century. We see that in all aspects of society. For those of us who attended the AIB meeting in Vancouver in 2014, you cannot help but realize that despite its geographic location in North America, it is truly a multicultural city that represents a confluence of East and West. For attendees at the AIB meeting

in Bengaluru (or Bangalore, to many) in 2015, we were amazed at the diversity there in terms of religious traditions and cuisine. At AIB, I would like us to not only continue, but more importantly, accelerate and increase our efforts to celebrate these differences. I am using diversity in the broadest sense of the word to encompass gender, different countries of origin and/or domicile, ethnicity, economies at different stages of economic/technological development, differences in income level, spiritual traditions, stages of career development, research focus and methodology, and sexual orientation.

Research shows that diversity can be a double-edged sword. My own observations and personal experience in growing up and living in multicultural societies on two continents have helped me better understand the implications of diversity. On the one hand, diversity can create challenges in terms of misunderstanding that arise from these differences and, hence, has the potential for creating conflict. On the other, it offers excellent opportunities for enhancing the richness associated with different backgrounds and traditions to create a more exciting whole.

Our journal, *JIBS*, has won many accolades and has recently been included as a 4* world elite category journal. Kudos to the current editorial team and its predecessors for their wonderful work in making this happen. With regard to outlets for our research, two important

issues were discussed at the AIB Board meetings in Bengaluru—the first pertains to the upcoming search for a new Editor-in-Chief for *JIBS* for the 2016-2019 term. Nominations (including self-nominations) and letters of interest must be sent to the AIB Executive Secretariat (aib@aib.msu.edu) with a copy to Tomas Hult (hult@msu.edu) by September 15, 2015. Second, given the growing popularity of international business research, the Board has adopted a resolution to work steadfastly towards launching a second journal in the policy area—more details on this will be provided in the coming year. In addition,

once the second journal has been launched, we will start work on developing a third journal. I will chair a committee to identify the protocol to be used in identifying and launching future AIB journals to better meet and reflect the broad array of research interests and professional aspirations of all our members. While diversity embraces differences, it doesn't mean that anything goes. Hence, it is important to formalize the procedure for identifying the areas/foci of future journal(s) that could best meet the needs of our members so that we can proceed in an orderly and efficient fashion to ensure their success. While on the subject of JIBS, in the event that you have missed it, to broaden the appeal of our journal to our current and prospective members who are non-native speakers of English, beginning this

A decade or so ago, Lorraine Eden founded the Women in the Academy of International Business (WAIB) to better meet the needs of women members. WAIB has been active in addressing gender issues since our Stockholm meeting in 2004. It is important to remember that participation in WAIB is not confined to women members only. In Bengaluru, WAIB sponsored three sessions, one of which focused on "Creating and publishing high-quality research on women and gender." Besides WAIB, the Board has received proposals to establish a Research Methods Special Interest Group (SIG). Another SIG proposal is for the Lesbian, Gay, Bisexual, Transgender and Intersex (LGBTI). The Board has given the sponsors of these initiatives a road map on how to attain SIG status, including the required number of signatures from members supporting the proposal, development of a governance structure, a plan for future activities, etc.

will be translated into the four most popular languag-

es in the world (in alphabetical order): Chinese,

French, Portuguese and Spanish.

In recognition that there are still many people in the world who are interested in international business but who are less privileged than many of us who live in the more developed regions of the world, the Board has signed on to Paul Beamish's (and the Ivey Business School's) 39-country project (http://www.ivey.uwo.ca/engaging/39-country-initiative/). Paul and his team manage occasional shipment of books and other teaching/reference materials to business schools in Senegal, Zambia, Zimbabwe, and other countries where there is dire need for such resources. Besides financial assistance, the Board will establish nodes to work with Paul on this worthwhile project.



Along the lines of giving back to those who are less fortunate than ourselves, the Board initiated a Social Responsibility Project in Bengaluru. A task force, under the leadership of Nakiye Boyacigiller, was formed to work on this project. Other members of the Social Responsibility Project, in alphabetical order, were: Susan Gupta, Susan Mudambi, Usha Raghunath, Sri Zaheer, and myself. 39 participants signed up for visits to the two organizations selected for this purpose: Concerned for Working Children (CWC) which mission is to "empower children to organise themselves and identify, and solve, their problems" (http://www.concernedforworkingchildren.org/) and Association for Promoting Social Action (APSA). The latter's mission is to "work with the community at the grassroots, with the privileged sections of society and with the government towards preventing exploitation and marginalization of the underprivileged, and to evolve social paradigms based on values of justice and non-discrimination for those already in exploitative situations" (http://www.apsabangalore. org/about-apsa/). Local artisans were also available in the exhibition area throughout the conference to sell their arts and crafts. Our members were able to buy

lovely souvenirs at great prices and the proceeds from these sales raised over 84,000 rupees. While this sum may appear to be very modest by our standards, it is sufficient to, one, cover the wages of all the women who made these products; and, two, enable them to buy raw materials to make items for sale in the future. This win-win situation is truly meaningful and heart-warming! I have already initiated discussions on meaningful social responsibility projects that we can participate in the 2016 meeting in New Orleans. If you have suggestions, please let me know.

Thanks to the work of Elizabeth Rose, outgoing VP Administration, our AIB chapters around the world continue to flourish. This again represents an important aspect of diversity that services the needs of our members worldwide.

The Board will also support AIB mini-conferences. The first of these will be held in Milan on October 22–24, 2015. The organizers for the Milan conference are Torben Pedersen and Lucia Piscitello.

AIB will undergo a restructuring from its current status as an unincorporated membership assoication *to* an incorporated nonprofit corporation status. Other membership associations, such as the Academy of Management and the Strategic Management Society, have adopted this latter status. This

restructuring will provide liability protection for our members, the AIB board and staff.

As I said at the beginning of this message, unity in diversity can only work if it percolates from the grassroots up, rather than a top down approach. As such, please send me (tung@sfu.ca) your ideas on how we, the Board, can serve your needs. While I cannot promise miracles, I am a good listener and will bring your ideas to the attention of the Board.

Our 2016 annual meeting will be held in New Orleans, Louisiana (June 27~30). New Orleans (nicknamed the "Big Easy") is another multicultural location that represents the melting pot of African, American and French cultures. I look forward to celebrating this unity in diversity with all of you in New Orleans.

In closing, I am very honored to serve as your President and look forward to the opportunity of working with all members, irrespective of differences, to make AIB a genuinely welcoming and receptive professional home to *each* and *every one* of us.



The Locus of Global Innovation

New Orleans, Louisiana, USA June 27-30, 2016

The multinational enterprise (MNE) is a central unit of analysis for international business (IB) scholars. Despite the persisting imbalances across nations, MNEs continue to increase their global footprint, skillfully integrating their activities across the globe, leveraging their global presence with hybrid organizational forms in many instances. Nowhere is the impact of this global integration felt more strongly than in the arena of innovation—R&D and related activities. The interconnections between MNEs, entrepreneurs and local firms are shaping a new paradigm for global innovation. We invite your ideas, data and insights to explore the changing contours of global innovation.

A conspicuous characteristic of this global innovation paradigm is the tilt towards emerging markets. MNE investments in R&D in emerging markets are dramatically increasing, signaling a radical departure from the MNE structure early IB scholars had envisioned. Frugal innovation approaches and business model innovations are enabling resource-scarce emerging market firms to compete alongside MNEs from developed markets. However, in many of these markets, institutions that support innovation remain weak. It is not clear if, and how fast, emerging markets are moving out of the low-cost focus to innovation. How common is "reverse innovation" in



MNEs? We need to study emerging empirical realities to understand the locus of global innovation.

The intersection of global innovation and emerging markets presents great opportunities to address pressing social concerns. More and more MNEs aspire to using "business as a force for good" and creating "shared value." Be it clean water or rural education, social problems are intensely local. However, global non-profit organizations, such as the Gates Foundation, have ably connected local problems to develop global solutions, and apply them in a customized manner to the locale. IB scholars have for decades explored how organizations manage global integration and local responsiveness. How do we extend such models to a systematic study of social innovation?

IB scholarship has a rich tradition of contributing to policy dialogues, with its unique vantage point gained from its comparative studies across geographies. Given the diverse policy environments MNEs have to operate in, how do these shape MNEs' global innovation choices? How can we advance the contours of policy research as it affects global innovation and its value to the local economy?

Come, and let us together explore the future of global innovation and the role of MNEs in creating this future! See you in New Orleans!

Nominations Sought for Election of Officers to the Academy of International Business Executive Board for 2016-2019

he AIB Executive Board operates on a rolling basis, with new members elected annually to fill retiring positions. The Nominations Committee, composed of the three immediate Past Presidents of the Academy, for this year is Mary Ann Von Glinow (chair), Robert Grosse and Nakiye Boyacigiller. The committee is seeking nominations for the following three positions and will then present a slate to the membership for election.

President-Elect

One candidate will be nominated from among those previously elected Vice-President for either Program or Administration. The elected person will serve a three year term: as President-Elect for 2016-2017, President for 2017-2018 and as Immediate Past President for 2018-2019. The AIB President presides at all meetings of the Academy and of the Executive Board, appoints and instructs all committees and is responsible for the strategic direction of the Academy and for supervising the functions of the other officers and of the Executive Director.

Vice President Program-Elect

Two candidates will be nominated to serve a three year term: as VP Program-Elect for 2016-2017 and be responsible for organizing the pre-meeting activities for the 2017 Conference, VP Program for 2017-2018 and responsible for putting the 2018 conference program together, and as VP Program-Past for 2018-2019.

Vice President Administration

Two candidates will be nominated. The elected members will serve a three year term and will be one of three individuals serving as VP Administration on the Board. The VPs Administration have oversight responsibility for finances, membership and chapter relations. The AIB President determines the delegation and sequencing of the responsibilities between the multiple officers serving in this position.

AIB 2015 Bengaluru Conference Highlights



ver 850 scholars and invited guests representing 50 countries from around the world met in the emerging market of India for the Annual Meeting of the Academy of International Business. Hosted by the Indian Institute of Management, Bangalore (IIMB), the conference was held at the beautiful Leela Palace Bangalore. This year's Program Chair, Ram Mudambi (Temple University) and Pre-conference Program Coordinator, Charles Dhanaraj (IMD), worked extensively with the consortium and track chairs as well as the AIB Secretariat, to create a program of academically stimulating sessions combined with engaging executive plenary speakers.

As is tradition, the preconference JIBS Workshop, Doctoral Consortium and Junior Faculty Consortium were held the day before the general AIB conference providing mentorship and networking opportunities from senior AIB members to doctoral students and junior faculty members. Added to the conference program this year were two new initiatives. The first was the addition of a preconference Research Capacity Workshop focused on strengthening doctoral programs and improving the research culture in developing country business schools. The second was an opportunity for attendees to visit a local third sector social organization to learn how these innovative groups develop creative solutions to some of India's toughest challenges.

The conference opened with the traditional lighting of the lamp of knowledge by faculty from our host school followed by introduction of this year's International Educator of the Year award recipient, Nick Binedell, recognized for his contributions as the Founding Director and Dean of the Gordon Institute of Business Science at the University of Pretoria. The AIB Fellows Plenary followed featuring keynote speaker and Executive of the Year, Kiran Mazumdar-Shaw, the first woman executive to be honored by AIB. The conference theme of "Global Networks: Organizations and People" was addressed in her keynote speech as it relates to the global biopharmaceutical industry.

Each day of the conference began with the popular Fellows Café sessions bringing fellows of the AIB together with members for informal discussions. Attendees followed their interests by choosing from thirteen parallel sessions of panels, competitive and interactive session papers. Special sessions featured a combination of academics and practitioners, *Scholarship in Practice*, designed to encourage stimulating discussions between IB scholars and practitioners in business and government, were interwoven throughout the program.

Harish Manwani, Chairman of Hindustan Lever and former COO of Unilever joined Dr. Ashutosh Raghuvanshi, Deputy Chairman and Group CEO for Narayana Health for a Special Executive Plenary with



each addressing the challenges of balancing competitive advantage with social responsibility and sustainable practices. A number of other featured plenary sessions recognized award winners. Among them, the AIB Fellows' Eminent Scholar award plenary honored Dr. W. Richard Scott, retired from Stanford University. John Cantwell, *JIBS* Editor, chaired the 2015 JIBS Decade Award session honoring Klaus Meyer and Mike Peng for their paper, "Probing theoretically into Central and Eastern Europe: transactions, resources, and institutions".

Perhaps the most exciting addition to the AIB conference this year was the AIB 2015 app! Members enjoyed the new mobile access to the conference program, maps of the venue, following instant posts

and social networking. Once again local artisans work was featured for sale and members connected with representatives from their local regional chapters at the "Meet Your Chapter" exhibit booth.

We would like to extend our appreciation to our host institution, the Indian Institute of Management, Bangalore (IIMB), with special thanks to Director Sushil Vachani and the local chair (as well as AIB India Chapter chair), Dr. S. Raghunath, for your outstanding dedication and commitment in making AIB 2015 an incredible success.

Just off the Press

- ⇔ Born Globals, Networks, and the Large Multinational Enterprise: Insights from Bangalore and **Beyond** (Routledge, ISBN: 978-1138787797) is a new release by Shameen Prashantham (CEIBS, China). Focusing on international entrepreneurship, this research book explores the accelerated internationalization of young firms. Known variously as international new ventures (INVs) or "born globals," such firms have come to be viewed as legitimate actors on the global stage alongside large multinational enterprises (MNEs). However, the current approach taken by scholars – studying large MNEs and born globals separately – is questionable. This book explores the crucial MNE/INV interface – a fascinating, yet under-researched relationship in international entrepreneurship. Drawing upon a decade of case-based research, the author argues that the MNE influence on born globals must be considered more carefully and suggests how new ventures can leverage MNE networks in the pursuit of their rapid internationalization. Furthermore, it demonstrates that, as firms enhance their levels of innovation, new pathways emerge via multinational corporation networks, a phenomenon vividly demonstrated in the emerging economy context of the Bangalore software industry.
- ⇔ Handbook of Emerging Market Multinational **Corporations** (Edward Elgar Publishing, ISBN: 978-1782544999) edited by **Mehmet Demirbag** (University of Strathclyde, UK) and Attila Yaprak (Wayne State University, USA) focuses on why emerging market multinationals internationalize, how they do so and the advantages they explore and exploit as they internationalize. The Handbook highlights the requirement for new perspectives on theory and managerial practice to better comprehend this phenomenon. Internationalizing firms from emerging markets are sweeping the global economy. Here, expert contributors offer interesting insight into emerging market multinationals' internationalization drivers, growth processes and expansion, and underscore similarities and differences between developed and emerging country internationalizing firms. Case

- studies from emerging market economies are presented, including corporations from China, Egypt, India, Thailand, Russia, and South Africa. Revised perspectives on internationalization theory are proposed, addressing changing global value chain configurations, institutional distance between home and host countries, the role of governments and preferred modes of entry into foreign markets.
- ⇔ Handbook on International Alliance and Network Research (Edward Elgar Publishing, ISBN: 978-1783475476), is edited by **Jorma Larimo** (University of Vaasa, Finland), Niina Nummela University of Turku, Finland) and Tuija Mainela (University of Oulu, Finland). Over the past few decades, alliance and networks have been generally examined individually. This Handbook sheds new light on this research by combining the two topics and focuses on highlighting their similarities. The expert contributors discuss topics surrounding the state-of-the-art in alliance and network research such as organising opportunities in international entrepreneurship; transaction costs in alliances and joint ventures; diaspora networks; and national culture and international alliances. They go on to look at conceptual developments relating to born globals; subsidiary performance; internationalisation; and knowledge transfer and organisational learning. Finally, they present empirical evidence of international alliances and networks. They combine diverse types of studies including literature reviews, conceptual papers and empirical studies in order to provide the reader with a comprehensive understanding of the topic.
- **The Routledge Companion to International Entrepreneurship* (Routledge, ISBN: 978-0415829199) is edited by Stephanie A. Fernhaber (Butler University, USA) and Shameen Prashantham (CEIBS, China). The domain of international entrepreneurship has continued to gain momentum in an era that sees entrepreneurship and globalization as critical issues in the world of business. Given the flourish of new research in this area, there is a need to

provide an up-to-date perspective on the field and its future. This volume draws together a team of experts purposely selected from both the entrepreneurship and international business fields to present a comprehensive resource on the cutting-edge conversations within international entrepreneurship. This prestigious reference book will offer students and researchers an introduction to leading scholarship in international entrepreneurship and also serve as a catapult for future research.

⇔ Tracing the Roots of Globalization and Business Principles, Second Edition (Business Expert Press, ISBN: 978-1631572302) by Lawrence A. Beer (Arizona State University, USA, retired). The author, as a young naïve export director taking his first overseas trip, hears a common refrain often directed at Americans, "As you Americans are fond of saying, let's get down to business." Not until years later did the former adolescent international executive realize that such expression was offered tongue in cheek. Nothing could be further from the truth. The process of exchange leading to intercontinental trade was a human activity as old as mankind. The roots of commercial globalization and the business principles that evolved to sustain it were and still are essential components to the growth of civilization. This book offers a valuable insight into the chronicled stages of globalization, the contributions to its evolution by various societies and its emergence as a relationship building instrument with similar worldwide practices; a prologue to all business courses.
