### **Beyond Ourselves: AlB's Social Initiatives**

Dear colleagues,

Last Friday, I picked up my visa from the Indian Consulate here in Istanbul. I can't tell you how excited I am about our upcoming meeting and somewhat embarrassed to admit that this will be my first visit to India, one of the most important economies and democracies in the world. Still it is finally happening and I couldn't be happier.

Program Chair Ram Mudambi and pre-conference program coordinator Charles Dhanaraj have been working diligently, along with the support of the many track chairs, consortium leaders, our local Chair, Professor S. Raghunath and many others to put together a fantastic program for all of us. For the last two years or so several of us on the board have been thinking about ways we could more deeply engage with and support the community hosting us at our annual meetings. Unquestionably, our greatest impact is with our scholarship and that endures far beyond any meeting. Nor is the effect we have on the local economy insignificant. And of course, AIB local hosts and program chairs have always worked to provide us ample opportunities to learn about and enjoy the local context. This year, and hopefully in the years to come, we would like to go beyond this in order to engage more closely with the local community. Working together with our local host Professor S. Raghunath and his wife Usha Raghunath, a team of AIB members (Rosalie Tung, Sri Zaheer, Susan Mudambi, Susan Gupta, and myself) have sought to identify a worth-while non governmental organization for a group of us to visit. The idea is to see first hand and learn how these innovative organizations are dealing with some of India's key challenges. We have two organizations that have agreed to host visiting delegations (you need to choose one or the other) the afternoon of **Friday, June 26**th, the day before our conference starts:

**APSA**, Association for Promoting Social Action. APSA started in 1981 as a crisis intervention center and since then has supported more than 15,000 children in distress: child laborers, street children, victims of abuse, trafficked and abandoned children. <a href="http://www.apsabangalore.org">http://www.apsabangalore.org</a>

**CWC**, Concerned for Working Children. The CWC, was founded in 1986 has been working to empower working children to organize themselves to identify and solve problems. opportunity to set up an information booth amongst our exhibitors. Finally, we will be providing you with a chance to make a donation to one of a few organizations during the meeting. More importantly, we hope some enduring relationships might emerge from these engagements.

Perhaps it is the spirit of India that inspired the AIB board to move ahead with another project that we have been discussing for the last few years. Earlier this year, the AIB Executive Board decided unanimously to support the 39 Country Initiative. Founded at the Ivey Business School, Western University by AIB Fellow Paul Beamish, the 39 Country Initiative seeks to help alleviate the resource constraints facing management educators and students in some of the poorest countries in the world. The lack of well-stocked libraries, the high cost of business cases, books and photocopies are all impediments to management education in these countries where it is so greatly needed. The 39 Country Initiative is a multi-pronged initiative to help rectify this situation. Ivey, the second largest producer and distributor of business cases in the world, is offering its cases at zero cost to all registered institutions within these countries.1 In addition, they have mobilized their community to ship used books to universities in need in Africa. At our 2013 Annual meeting in Istanbul, Paul Beamish made a presentation to members of the AIB board seeking our support for the *39 Country Initiative*. This January the AIB Executive Board unanimously decided to support the project. This support includes marketing efforts, a place on our website and funding support to help defray shipping costs from each university to the recipient school.

In addition to Paul and his colleagues and students from Ivey, two of our AIB colleagues have also joined the project. Starting this semester, Susan Mudambi at the Fox School of Business at Temple University in Philadelphia, USA and Peter Liesch at UQ Business School at the University of Queensland, Australia, have offered to serve as nodes (collection points) for this project. We thank both of them and their students for joining this worthwhile venture. If you have books to give and live in proximity to Ontario, Philadelphia or

Queensland, send them along!

Obviously, we need more nodes to become part of the network to collect books from other geographic locations and to ensure that the local transportation costs not be prohibitive. An ideal node would stretch our geographic reach, be in close proximity to a seaport and be major metropolis with numerous universities. Cities that come to mind are Los Angeles, London and Miami. Upon the untimely passing of Alan Rugman, there was as an outpouring of suggestions as to how we should honor his legacy and lasting contributions to AIB. On the recommendation of a Fellows committee comprised of Jean Boddewyn, Robert Grosse, Arie Lewin and chaired by

Tim Devinney, and based on the unanimous approval of the Executive Board of AIB, the Haynes Most Promising Scholar Award given for the best paper from a scholar under the age of 40 will be renamed the *Alan M. Rugman Most Promising Scholar Award*. As Tim Devinney argued in his report:

The logic for renaming the Most Promising Scholar award for Alan Rugman is not just the impact that Alan had (and continues via his work) on our field but his commitment to the engagement and development of junior scholars. He was one of our most prolific Fellows in terms of PhD student supervision and was avidly involved in all aspects of junior faculty and doctoral student development via consortia, workshops, cajoling and mentoring. It would be superfluous to continue the litany of his accomplishments in this area and the extent to which his involvement is perhaps second to none amongst the Fellows.

I am delighted to announce that the newly named *Alan M. Rugman Most Promising Scholar Award* will be awarded this year in Bengaluru. We will always miss Alan, but having a chance to reminisce about him while we listen to the work of some of our best young scholars will be deeply meaningful. I am sure that Alan would have approved.

Looking forward to seeing many of you in Bengaluru!

### Focus on AIB Chapters

In this issue, I have the pleasure of introducing two more of our very active AIB chapters: Latin America (AIB-LAT) and Southeast USA (AIB US-SE). Both chapters have experienced remarkable growth and transformation over the past five years!

### **Latin America**

The AIB-LAT chapter is young; its inaugural conference preceded the AIB annual conference in Rio de Janeiro in 2010. Led by current chapter chair William Newburry, of Florida International University, the fifth annual AIB-LAT conference was held during 22–24 January 2015, in Santiago, Chile. The conference, which had over 100 participants, representing

countries across the region, along with Australia, North America, Asia, Europe, and the Middle East, was hosted by the ESE Business School at Universidad de los Andes and chaired by Jon Martínez. Some 20 percent of the conference attendees were from the local business community, yielding an interesting mix of academia and practice.

The 2015 AIB-LAT conference began with two intensive, research-oriented events: a doctoral consortium (organised by Santiago Mingo) and a JIBS paper development workshop. In addition to a broad range of paper presentations (organised by William Newburry), the main conference included some outstanding plenary sessions, again representing both research and practice. Plenary talks by Lourdes Casanova, José de la Torre, Mansour Javidan, and Belén Villalonga were well-received, as was the panel session on publishing, presented by Jorge Carneiro, Sumit Kundu, and Mary Zellmer Bruhn. Conference attendees also had the opportunity to gain important insights into the Latin American business environment through the executive plenary panel, which included the CEOs/Chairs of Multilatina companies Empresas Carozzi, Falabella, LATAM Airlines Group, and SURA Asset Management Latin America.

Congratulations are in order for Marcia Zabdiele Moreira (Universidade da Integração Internacional da Lusofonia Afro-Brasileira, Brazil) and Mario Henrique Ogasavara (Escola Superior de Propaganda e Marketing, Brazil), winners of the Best Paper Award for their submission entitled "The Relationship between Institutional Aspects and the Expatriation Strategy in the Internationalization of Multinational Enterprises in Latin America."

Of course, the conference was not all work and no play! The gala dinner took place at Neuva Enotk, with a spectacular view overlooking Santiago, and the closing luncheon was held at the Concha y Toro Winery, followed by a vineyard tour and wine tasting.

### **US Southeast**

One of the AIB's older chapters, the AIB US-SE's leadership has transformed the chapter over the past several years. The 2014 AIB US-SE conference took place in Miami, Florida, on 23–25 October, hosted by Florida International University. Highlights of the program included a keynote presentation by Andrew Spicer that incorporated the conference themes of sustainability and emerging markets and a special "South Florida AIB Fellows" panel presentation.

With contributors representing 59 countries, the conference organizing committee of Peter Magnusson (chapter and conference chair), Anshu Arora (program), Susan Forquer Gupta (membership

communications), Irina Naoumova (sponsorships), and Sumit Kundu (local host) welcomed a record attendance of 342 registered participants to Miami. This attendance number reflected growth of 53% relative to 2013 and 470% over the past five years!

This remarkable growth is the outcome of a strategic decision taken by the chapter's leadership in 2010, aiming to expand the chapter's reach.

The AIB US-SE focuses on providing a developmental conference with something to offer to anyone with an interest in international business research. The developmental focus ranges from a focus on high-quality reviews for the conference to providing publishing opportunities through special-issue affiliations with several high-level journals.

Consistent with the focus on providing developmental opportunities, the 2014 AIB US-SE conference included a doctoral consortium, organized by John McIntyre and Bill Newburry (yes, the AIB-LAT chapter chair!), which included 21 students from a variety of countries. In a new initiative for the chapter, the conference also offered a new faculty consortium, led

by Mark Peterson and Tom Lenartowicz and enjoyed by 18 junior faculty members. The conference also included a PLS-SEM seminar led by Joe Hair; the seminar attracted 43 participants. With support from the AIB Executive Board, the AIB US-SE was able to allocate funding toward travel stipends for students and participants from low-income countries.

The AIB US-SE conference showcases world-class scholars, who act as role models and mentors to other participants. In addition to the traditional faculty and PhD student researchers, the AIB US-SE chapter conference also welcomes participation from younger scholars. Promising researchers at the undergraduate and master's student levels are invited to present their work; this serves as an introduction to future PhD studies. For many junior scholars, the AIB US-SE conference serves as a valuable gateway to the AIB annual conference.

The 2015 AIB US-SE conference will be held on 12–14 November, in Savannah, Georgia. The conference will be hosted by Savannah State University in Savannah, GA, and chaired by Anshu Arora. Recognizing Savannah's importance as a gateway to the region, the conference theme will focus on international trade and global supply chains. AIB President-elect Rosalie Tung will be the keynote speaker. The submission deadline is 15 July 2015; see the AIB-SE website (<a href="http://www.aibse.org/">http://www.aibse.org/</a>) for more details about this energy-filled and very successful chapter!

The editors invite contributions to this special issue on the role of financial and legal institutions in corporate governance around the world. Their goal in this special issue is to integrate the strengths of finance, law, and international business scholars to gain insights into resolving asymmetric information and the associated governance problems in international business.

Submissions are encouraged from scholars that use different theoretical and empirical approaches to understand corporate governance, financial intermediation and growth in emerging and developed markets with an emphasis on finance, law and in politics.

# Zoom In, Zoom Out, and Beyond: Locational Boundaries in International Business

The goal of this special issue is to encourage research that (a) goes beyond our understanding of traditional IB to focus on the cross-border activities of MNEs across multiple geographic levels; (b) examines the multi-level effects of geographic layers on strategies and performance of MNEs and their foreign subsidiaries; and (c) studies the effects on international business of interactions between

different geographic levels of authority or organization themselves. The editors particularly welcome manuscripts that can stimulate dialogue between different fields of scholarship within and outside the realm of the conventional IB studies. For example, theoretical insights of economic geography, regional science, political economy, and international organization may shed new light on the development of the economic activities of MNEs across economies at different geographic levels of locations. Similarly, recent theoretical and empirical advances in regional and urban studies, geography, political science, sociology, and anthropology may provide new theoretical perspectives for examining the nested structures of economic activities of MNEs across locations.

The editors welcome both theoretical and empirical contributions, and papers that address regional and subnational issues relating to international business activities.

# The Creation and Capture of Entrepreneurial Opportunities across National Borders

The goal of this special issue of *JIBS* is to encourage research that deepens knowledge of the creation and capture of entrepreneurial opportunities across national borders by diverse organizational types such as international new ventures (INVs), born global firms, micro-multinationals, corporate entrepreneurs, family businesses, and social and non-profit ventures.

The proposed special issue focuses on the creation and capture of entrepreneurial opportunities across national borders. The editors seek papers that advance theoretical perspectives and provide valuable insights and new knowledge to enrich international entrepreneurship scholarship, and also that guide practitioners and policy-makers. The editors invite submissions from scholars who, individually or collectively, draw on varied theoretical perspectives, adopt diverse empirical approaches, and investigate at multiple levels of analysis. Submissions that provide conceptual clarity of international entrepreneurship as pursued by different types of market actors, and those that provide new empirical contributions are particularly encouraged. Well-conceived submissions antithetical to this domain are welcome too, provided they make a meaningful contribution to the international business field more generally.
